- Finance: Provide a report concerning the African-American Chamber of Commerce. Why is money still separate for African-American Chamber, Chamber of Commerce and Urban League? (Councilman Gilbert)
- RPA: How are priorities set by TIP? (Councilman Gilbert)
- Capital Budget: The sidewalk (SRTS) project for Lakeside has been not implemented while Woodmore) is being included. Which will be done first and when? (Councilman Gilbert)
- YFD: List of contract funded programs for YFD. (Councilwoman Coonrod)
- ECD: Will the Affordable Housing Fund be appropriated to different agencies? (Councilwoman Coonrod)
